A WIN-WIN OPPORTUNITY!

This is your opportunity to make a difference in education by making an important contribution to our school and receive an Arizona State Income Tax Credit for the full amount of your contribution!

IT IS YOUR OPPORTUNITY TO HELP

Arizona Tax Law (ARS §43-1089.01) enables tax payers to earn a tax credit up to \$200 (\$400 per married couple) by making a contribution to extracurricular activities at any Arizona public or charter schools. Extracurricular activities such as sports, band, speech & debate and overnight field trips qualify since these fees depend on fees paid by students who participate. In addition to tax donations can also be used to fund character education programs taught as part of the schools curriculum. Now, tax credit money can be used to help fund these activities and programs for students!

WHO CAN DONATE?

The tax credit is available to all State of Arizona tax payers, regardless of whether they have children in school. Contributions from businesses are always welcome, however such contributions cannot be used to obtain tax credit.

IT IS YOUR CHOICE

You may donate up to \$200 (\$400 for married couples). The amount of your donation will determine the amount you may claim as a state tax credit. For example, if you donate \$100, you can claim \$100 for your state tax credit.

Your donation may be split into payments, among more than one public or charter school in Arizona or between various activities. No matter how your donation is divided, you will still only qualify up to \$200 state tax credit (or \$400 for married couples).



CONTRIBUTIONS GET THE MONEY WHERE IT NEEDS TO GO

Tax Credit contributions are donated directly to the school, not to the state. These funds are not subject to revenue control limit that prevents schools from spending more than a fixed amount for programs. Your donation will go exactly where you want it to go, immediately helping more students become involved in fun, meaningful, life-enhancing activities!

IT'S THIS EASY!

By completing the Tax Credit Donation Form on the back of this brochure, you will have lots of ways to say "YES!" in support of Academy Adventures Midtown. Here is how the tax credit works:

- Check the dollar amount up to \$200 (\$400 per married couple) that you would like to contribute.
- Make check payable to: *ED AHEAD, INC.*
- Select the box next to the activity category you would like to fund. If you would like to support all activities at the school, just check the "Any Extracurricular Activity" box.
- Complete the tax donation form with your name and address.
- Drop the form and your check off to the school office and keep the bottom portion as your receipt. You may also mail the form and check in. ***Please note: donations must be received in time to be deposited by the end of the day, December 31.***

ARIZONA TAX CREDIT FACTS

- ⇒ Up to \$200 for single individuals or head of household can be claimed as tax credits.
- ⇒ Up to \$400 for married tax payers filing jointly.
- ⇒ Any public or charter school, grades K-12, qualify to accept tax credits donations.
- ⇒ To qualify for a tax credit, you must make a cash donation or pay fees to a public or charter school in the State of Arizona in support of extracurricular activities or character education.
- ⇒ School sponsored activities that require students enrolled in the school to pay a fee to participate are considered extracurricular and qualify for the tax credit.
- ⇒ Character education programs are defined in ARS §15-719. The program must include instruction in at least six (6) of the following areas: truthfulness, responsibility, compassion, diligence, sincerity, trustworthiness, respect, attentiveness, obedience, orderliness, forgiveness and/or virtue.
